#### Call 2019 – New features

- Increased funding for Western Balkans and Africa!
- Project period will start 2 months later than before: on 1.8.2019.
- The project duration can be either 24 months or 36 months. 16 months option is no longer available.
- Serbia will become a programme country as of 2019, so mobility with Serbia should be funded through intra-European mobility (KA103). Projects funded earlier will however run as granted.
- Chile and Uruguay will move from DCI Latin America envelope to PI America envelope.
- In the DCI Latin America envelope Paraguay will no longer be counted as less developed country.

#### **Traineeships introduced in 2018**

- Student mobility for Traineeships as a novelty in ICM since 2018
  - Incoming and outgoing, all degrees, all fields
  - Host can be e.g. public and private organisation, enterprise, NGO etc.
  - Minimimun duration 2 months (or 3 months if combined with studies within one mobility). Maximum 12 months.
  - Monthly grant the same as for studies: no top-ups
  - Not necessary to name the host organisation at the application stage
  - LA to be signed by 3 or 4 parties: student, home institution, host organisation (and coordinating programme country institution in case of incoming mobility from partner countries)

#### Digital traineeships – Calls 2018 and 2019

- The Commission will be tracking traineeships in 'digital skills' in Horizon 2020
   Associated Countries participating in ICM:
  - Albania, Bosnia and Herzegovina, Montenegro, Serbia, Israel, Moldova,
     Switzerland, Faroe Islands, Ukraine, Tunisia, Georgia ja Armenia
- Labour market is in need of more people with digital skills, "skills mismatch"
- HEIs are encouraged to implement
- No separate application system + simple reporting:
  - Marked in LA "Traineeship in digital skills: Yes □ / No □ "
  - "Flagged" in Mobility Tool+
- Monthly grant and documentation the same as for other traineeships

#### Digital traineeships

- Any traineeship will be considered digital as such when one or more of the following activities are practised by the trainee:
  - Digital marketing (e.g. social media management, web analytics); digital graphical, mechanical or architectural design; development of apps, software, scripts, or websites; installation, maintenance and management of IT systems and networks; cybersecurity; data analytics, mining and visualisation; programming and training of robots and artificial intelligence applications.
  - NB: Generic customer support, order fulfilment, data entry or office tasks are not considered in this category

# Staff mobility opens for non-academic organisations 2018

- Staff mobility has become available for other organisations than higher education institutions: public and private organisation, enterprises, NGOs (same as for the traineeship mobility)
- Not necessary to name the host organisation at the application stage
- Min. and max. duration of staff mobility the same: 5 days to 2 months
- Mobillity agreement between HEIs, host organisation and staff member
- Grant agreement between Programme Country HEI and staff member

#### **STA & STT**

- Staff mobility for Teaching (STA) allways from a non-academic organisation to an HEI
  - A programme or partner country HEI can invite staff from enterprise to teach at the HEI
  - Call 2019: No minimum number of teaching hours for invited staff from enterpises
- Staff mobility for Training (STT) allways from an HEI to a non-academic organisation
  - Staff members of a partner country HEI can have a training period at a public or private organisation or enterpise in the programme country (but not vice versa)

#### **Budget**

- Call 2019: altogether 3,3 million euros available for twelve geographical envelopes.
  - 3 133 257€ from EU's external cooperation funding instruments (Heading 4)
  - 180 000€ from European mobility funds (Heading 1) for outgoing student mobility in DCI and EDF envelopes
- Special attention to Western Balkans and Africa where there is additional funding available!



Focus of mobility, where possible, on incoming student mobility; incoming mobility of younger members of staff; a good geographic spread; promoting cooperation with less experienced countries in the region; and encouraging partnerships with new HEIs.

#### **Application procedure**

- Only one application to international credit mobility per one HE institution
  - all partner countries in one application
  - quality questions filled in separately for each partner country
    - 4 questions per country, following the assessment criteria
    - answers must cover both the applicant HEI & Partner Country HEIs involved

Coordination / support from international office

#### **Mobility consortium**

= Min. 3 organisations 2 of which should be HEIs from the same country (=Finland)

- 1. Mobility consortia must apply for a **Consortium Accreditation** with a separate application form **(KA108)** 
  - If awarded, accreditation valid for 3 consecutive calls
- 2. If an earlier accreditation has expired, consortia must apply for an accreditation renewal
- 3. Same procedure for applying for funding as individual HEIs

# Cooperation encouraged also with small and less developed countries

- Geographical balance
- Western Balkans and Africa
- Complementarity with other funding schemes

# Old established partnerships vs new openings?

- Focus on student mobility
- Staff mobility good way to start cooperation with new partners
- No limitations to number of partner countries
- Be realistic in number and lenght of mobilities
- Consortium as an option

#### **Additional tips**

- Partner Country HEIs must be recognised by competent authorities of their country
  - In case of doubt, please check! (National Erasmus+ Offices, EU Delegations, national authorities, European Commission, NAs)
- Linking ICM cooperation to education export goals
  - Comparable to any other form of aimed future cooperation between partners
  - Desribe under quality questions
  - → Mobilities funded with Erasmus+ must be in line with the programme rules
- How to include disadvantaged groups of participants in the project?
  - → Flag in Mobility Tool+
